



## Value Acceptance + Property Data Service Providers

Updated May 13, 2024

Below are value acceptance + property data service providers that have met basic requirements for offering data collection field services, data collection technology, or integration to the property data API. Additional service providers are being evaluated, and this document will be updated periodically with new additions.

To support implementation of value acceptance + property data and promote data collection maturity, Fannie Mae will perform initial data quality assessments of all property data collections delivered to the Fannie Mae Property Data API by a new data collection service provider for a defined period. As these initial assessments are completed, the service provider will be contacted to participate in coaching sessions with Fannie Mae representatives to communicate assessment conclusions and inform service provider data collection best practices.

Fannie Mae data quality assessments could result in the removal of a service provider from this matrix.

Use of the Uniform Property Dataset is required as of April 1, 2024, when Fannie Mae's proprietary Property Data Standards v6 was retired for all new cases.

NOTE: Fannie Mae does not endorse any service provider and does not represent or warrant that any service provider will meet a lender's requirements. Lenders must establish controls to manage and monitor service providers in accordance with their own obligations. Please contact the service provider directly for more information on the specific services they provide.
