



## Search Commitments Export File Specification

In the Pricing & Execution – Whole Loan® application, you can export search results on the Advanced Search screen for all commitments in one .csv file.

### The Search Commitments Export file format will conform to the following layout:

- Row 1 of the .csv file will have the title " === Pricing & Execution - Whole Loan === " in the first column:
