The Housing Channel's mission is to help people build wealth through homeownership – Community First helps the organization develop affordable housing for their customers.

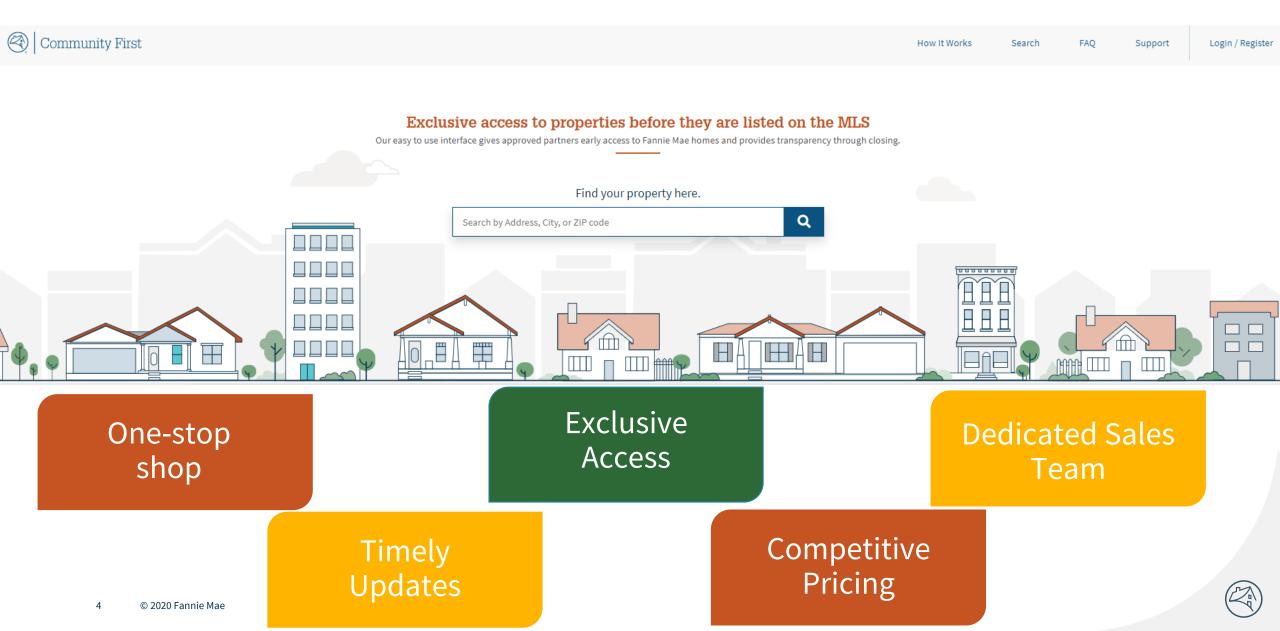

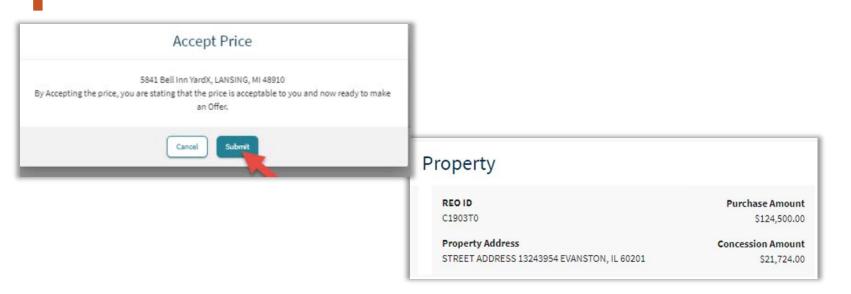
The Community First platform is available to approved organizations focused on community stabilization and providing affordable housing.

Definition	A local, municipal, or state government agency	A recognized 501(c)3 organization or church	A for-profit working with a non-profit or as a recipient or administrator of public funds, which includes funds from a government agency, foundation funds, leveraged private financial institution and/or consortium funds
Requirements	 Public Funds Designation Letter (letter on government letterhead, maintaining that person is an employee of the respective entity and is purchasing properties as an agent thereof) Signature Authority 	 501(c)3 documentation (not required for churches) Tax-exempt documentation (only required for churches that do not have 501(c)3 documentation) Signature Authority 	 Articles of Incorporation Letter from public funding agency or non-profit, authorizing the entity to purchase properties on its behalf Signature Authority



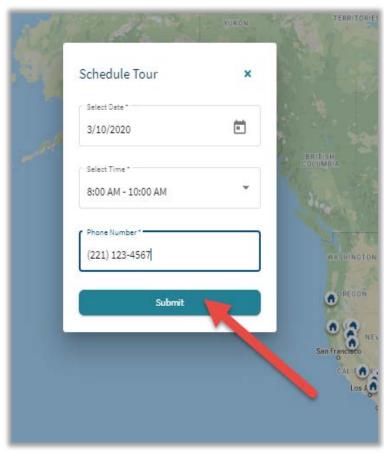

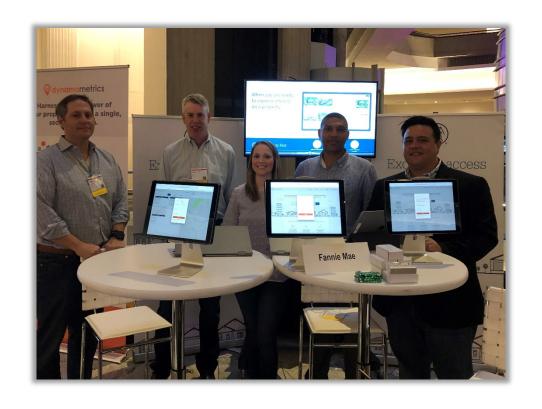

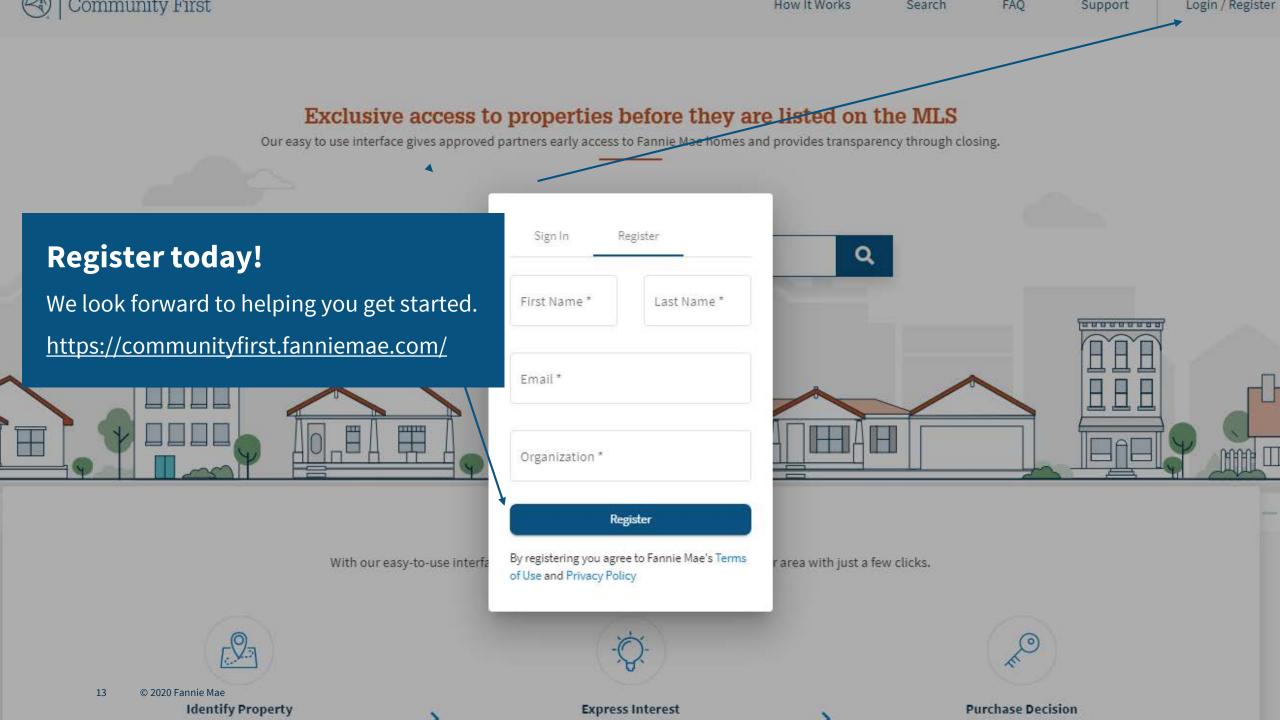
