

# DU for Government Loans Integration Impact Memo

Sept. 2021 Release

Aug. 11, 2021

During the weekend of Sept. 18, 2021, Desktop Underwriter® (DU®) for Government Loans will be updated to support the DU Specification MISMO v3.4 (DU Spec) version 1.8.2 and FHA-mandated changes, as described in the [DU for Government Loans September Release Notes](#) to ensure that your integrated system(s) will be prepared to support this release.

**NOTE:** For ease of reference, this document generally uses the term “DU” to refer to “DU for government loans.”

## Support of the Updated Uniform Residential Loan Application

The DU V. 11.0 September Update Release Notes specified changes that are being made to support the updates made to the loan application data in the [DU Specification MISMO v3.4 \(DU Spec\) version 1.8.2](#) that was initially published on June 29, 2021 and updated on August 10, 2021. The Data Points below are related to the enhancements referenced in the Release Notes. Refer to the DU Spec V. 1.8.2 for additional information.
