To Mortgage Default Counsel:

Please note that in an effort to improve the quality of data in DRA we are planning to streamline delay enumeration options. Currently there are 64 events that can be reported in DRA. Depending on the event, data is either 'Required' or 'Optional'. These data points are called "Enumerations".

The enumerations below will be removed as of Friday, October 21, 2022. Aside from the "Unknown Delay", most of the enumerations below are seldom used. We understand that removing the Unknown Delay option may be of some concern, however there are 175 other enumerations to report the proper delay.

Please review the associated "DRA Delay Enumeration" list for alternative options. As needed, please contact your firm manager to discuss further.

| Enumeration Value | Enumeration Description |
|------------------------------|---|
| TO BE RETIRED | |
| 2MP in progress | 2MP in progress: Delay due to a loan being approved for 2MP. |
| 2MP in review | 2MP in review: A loan is currently being reviewed to determine 2MP eligibility. |
| HAFA | HAFA in progress: Delay due to a loan being approved for HAFA. |
| HAFA in review | HAFA in review: A loan is currently being reviewed to determine HAFA eligibility. |
| Proof Of Claim | Proof of Claim Objection Received: Delay as a result of an objection to the Proof of Claim (POC). |
| Refinance in Review | Refinance in Review: Delay due to the borrower applying for a refinance. |
| TILA | TILA: Delay due to a TILA regulation change and impact to applicable loans has not been determined. |
| Torrens Property | Torrens Property: A delay pending the completing of the Proceeding subsequent (pro sub) process. |
| Unknown Delay | Unknown Delay: A delay has occurred for unknown reasons. |
| Veterans Affairs Buy Down | Veterans Affairs - Buy down : A loan is currently under review by the insurer to determine if a buydown will be made in order to entice the VA to establish an "Upset Price". |
| Veterans Affairs Refund | Veterans Affairs - Refund option in review: A loan is currently under review by the VA to determine if a refund will be issued. |

We are also removing the following events as they were intended for use by servicers reporting in DMRS. As servicers no longer report in DRA, these events are no longer necessary.

If an event has a failed validation, IT WILL NOT report that event until it is corrected. If an error occurs on an import file, it will not load the file and the status will be ERROR.

Effective immediately firms are required to provide the "Foreclosure Sale Bid Amount" when entering event E0250, "FC Sale held". This change will impact enumeration number 70, "Foreclosure Sale Bid Amount". The foreclosure sale bid amount should be the bid amount used at the time of the foreclosure sale.

Regarding future changes to DRA, below is a list of items currently planned. As changes are made we will endeavor to ensure additional communication and or direction is provided as needed.

| Fannie Mae expects firms to engage in a prompt reconciliation of files to ensure accuracy of data uploaded. It may be necessary to adjust the case status relative to current loan events, i.e. liquidated/current loans from "Active/On Hold" to "Inactive". | |
| Updated attorney FAQ | Early October |
| Updates to Loan Summary page adding additional data points including the last payment date, loan delinquency status, loan liquidation date and loan liquidation code. These additional data points will be added to DRA from servicer data reported in other applications. | Mid-October |
| Updates to smart loan search function | Mid-October |
| Missing Document delay to include missing document type in display and downloads | Mid-October |
| Additional reporting functionality with expanded case filters | End of October |
| Enhanced user guide | End of October |
| Delay event fix so that delay events will update case status to "On Hold" | TBD |
| Change "Attorney Case #" data from "Optional" to "Required" for all reported foreclosure events. This change will impact enumeration number 54, "Foreclosure Attorney File Identifier". | TBD |
| Although there is no defined implementation date currently, we do ask that firms not already providing this data make changes immediately to ensure the data is provided. | |
