Updated July 18, 2019

During the weekend of June 22, 2019, Fannie Mae will implement EarlyCheck[™] Version 6.0. These updates will apply to loans submitted to both the production and integration environments of EarlyCheck via the User Interface and Direct Integration and may require changes to users' systems or processes.

Please review the following updates, in addition to the <u>Release Notes</u>, to ensure that your integrated systems will be prepared to support this release.

July 18: This memo has been updated to reflect changes related to the recent announcement of the <u>Uniform Residential Loan</u> <u>Application (URLA) optional use period postponement</u>. (Red text signifies content that has been updated or added.)

MISMO Version 3.4 File (DU ULAD Specification)

At the direction of the Federal Housing Finance Agency (FHFA), the optional use period for the redesigned Uniform Residential Loan Application (URLA) form and corresponding datasets will not begin on July 1, 2019 as previously scheduled. As a result, acceptance of the new DU loan application submission file (MISMO v3.4) to EarlyCheck in the Fannie Mae Production Environment has been deferred until a later date.

The production environment of EarlyCheck will be updated to accept the Desktop Underwriter[®] (DU[®]) Spec MISMO v3.4 origination file format. This is part of the industry-wide adoption of the new Uniform Loan Application Dataset (ULAD) (Form 1003). The optional use period will run from July 1, 2019 to January 31, 2020.

During this period, we will accept the following origination file transactions in EarlyCheck.

- MISMO v3.4
- 1003 v3.2 flat file
- MISMO v2.3.1

NOTE: **NOTE:** When importing MISMO 3.4 files in the EarlyCheck user interface, lenders will select the File Type of "1003/MISMO 2.3.1 (Origination File)". The EarlyCheck Integration environment currently accepts the DU Spec MISMO v3.4 origination file format.

New and Modified Edits

EarlyCheck Version 6.0 will introduce new and modified edits to align with existing and upcoming Loan Delivery edit changes, including 7 that are changing from Warning-to-Fatal to Fatal. <u>The EarlyCheck Edit Messages list was published</u> 30 days prior to the planned release date with detailed information regarding new Warning edits.

New EarlyCheck Production Validation Errors

The EarlyCheck Version 6.0 release was implemented in the Fannie Mae Production Environment on June 22, 2019, except for the MISMO Version 3.4 File (DU ULAD Specification) updates.

Effective with this release, EarlyCheck introduced new error messages in the Production environment related to the new loan application submission file (MISMO v3.4).

How will this affect my integrated system(s)

When attempting to import a new DU loan application submission file (MISMO v3.4) to EarlyCheck in the Fannie Mae Production Environment via Direct Integration and the User Interface, the submission file will fail import and an error will be returned in the EarlyCheck XML and HTML Loan-Level Results.

Integrated systems that parse the EarlyCheck Loan-Level XML Results may require updates to support the new errors.

Integrated systems that receive and display the EarlyCheck HTML results should not be affected.

EarlyCheck Integration Test Environment – MISMO Version 3.4

EarlyCheck began accepting the new loan application submission file (MISMO v3.4) via Direct Integration in the Integration Test Environment on February 1, 2019.

On June 22, 2019, EarlyCheck began accepting the new loan application submission file (MISMO v3.4) via the <u>User Interface</u> in the Integration Test Environment.

NOTE: When importing a new loan application submission file (MISMO v3.4) via the User Interface, select File Type: 1003/MISMO 2.3.1 (Origination File).

EarlyCheck Import Validation Errors

During the import process, EarlyCheck will validate the loan application submission file (MISMO v3.4) against the DU Spec (MISMO v3.4) data requirements, enforcing both structure and data values.

How will this affect my integrated system(s)

Integrated systems that support the new loan application submission file (MISMO v3.4) and parse the EarlyCheck Loan-Level XML Results may require updates to support these import errors.

A Warning import error will not prevent the loan application submission file from processing; however, all Warning import errors should be corrected prior to reimport.

A Fatal import error will terminate the import process. All Fatal import errors must be corrected prior to reimport.

Upon successful import, EarlyCheck will evaluate the loan application submission file (MISMO v3.4) against existing Fannie Mae business rules, and applicable edit messages will be returned in the XML and HTML Loan-Level Results via Direct Integration and the User Interface.
