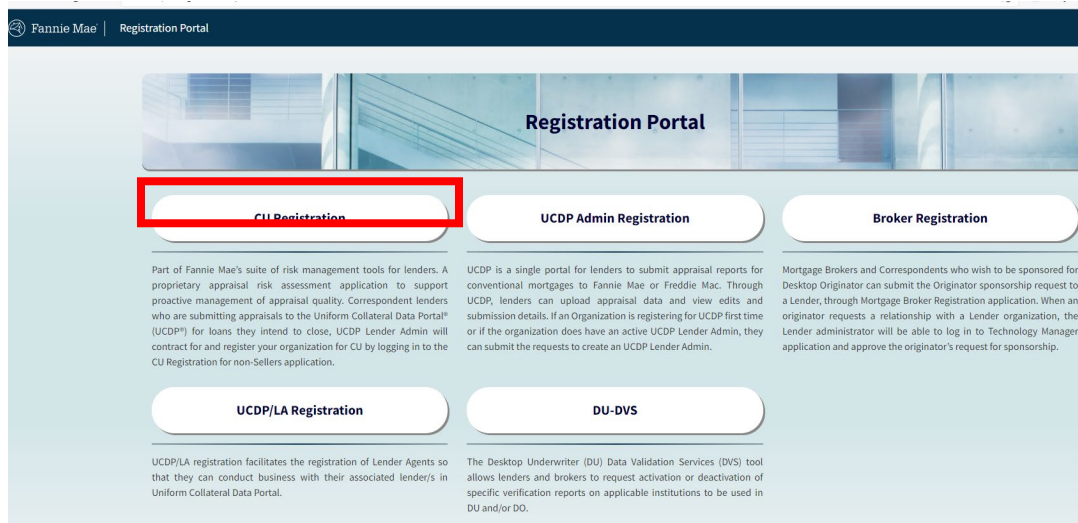




Collateral Underwriter Registration

Collateral Underwriter® (CU®) is a proprietary appraisal risk assessment application to support proactive management of appraisal quality and is part of Fannie Mae's suite of risk management tools for lenders. For Correspondent Lenders who are submitting appraisals for loans they intend to close through the Uniform Collateral Data Portal® (UCDP®), the UCDP Lender Admin may register the entity with which it is affiliated for CU by logging in to the CU Registration for non-Sellers application. Proceed to Technology Manager's Registration Portal and follow the steps below to register for CU:

1. Click **CU Registration** on the Registration Portal page.



2. Licensee must **click** the checkbox to acknowledge its agreement with the linked terms and conditions **and** must **enter** the name of the Authorized User or Delegate who is providing consent on behalf of the Licensee in the signature field. Select **Register**.
