# **ASAP Plus Reject/Redelivery Status Update**

Fannie Mae is enhancing the ASAP Plus certification process to remove the need to recertify loans that get updated subsequent to redelivery. Document Custodians will no longer be required to recertify loans that were previously certified due to a subsequent update. Refer to the table below for more information. To easily identify redelivered loans, a "Redelivery Indicator" will be added to the filter options on the Document Certification home screen.

Note: Document Custodians are still required to perform a daily reconciliation for ASAP Plus loans.

3	Lender redelivers ASAP Plus loan into an MBS Pool or Whole Loan Commitment	Document Certification updates loan record with commitment expiration date/pool information, retains "Certified" status	Document Certification updates loan record with commitment/pool information, retains "Certified" status
4	Lender initiates an update/redelivery	Document Certification updates loan record to "Rejected" status	Document Certification removes commitment expiration date/pool information from loan record, loan retains "Certified" status
5	Lender redelivers ASAP Plus loan into a new MBS Pool or Whole Loan Commitment	Loan has "Pending" status in NDC, a new Fannie Mae Loan number assigned	Loan retains "Certified" status in Document Certification, Loan is updated with new Fannie Mae Loan number

### **Effective Date**

The ASAP Plus Reject/Redelivery update and the "Redelivery Indicator" is effective September 23, 2019.



## **Document Certification Data Archival**

To improve overall system performance and usability, Document Certification will implement a data archival process. The application will only retain a six-month backlog of data. Data older than six months will be archived. If you require archived data, please contact custodian\_oversight@fanniemae.com for assistance.

#### **Effective Date**

The new data archival process is effective September 23, 2019.

# **Document Custodian Agreement Requirements**

An executed Custodial Agreement Form 2017 must be in place prior to any certification or custodian activities are performed for any Seller/Servicers. Document Custodians are responsible for ensuring that a fully executed Custodial Agreement Form 2017 is completed prior to certifying loans for all Seller/Servicers.

#### **Effective Date**

There is no change to this existing requirement and is actively effective.

# Servicing Guide Update: Servicer Notification Timing Requirements for Post-Delivery Servicing Transfers

To enable timely and accurate recertification of custodial documents, Fannie Mae has updated Servicing Guide A2-7-03, Post-Delivery Servicing Transfers to require that when a post-delivery servicing transfer occurs, the Transferor Servicer must advise the Transferor Document Custodian maintaining possession of the custodial documents within 30 days of the transfer effective date.

#### **Effective Date**

Servicers are encouraged to implement this change immediately but must do so for post-delivery servicing transfers that occur on or after January 1, 2020.

## **Effective Date**

The updated Active Document Custodian List and the Single-Family Custody Operations Points of Contacts and Analyst Assignments List are effective immediately.
