DU Version 10.3 March Update Integration Impact Memo

Jan. 23, 2019

During the **weekend of March 23, 2019,** Fannie Mae will implement an update to Desktop Underwriter[®] (DU[®]) Version 10.3, as described in the Desktop Originator[®] (DO[®])/DU Version 10.3 March Update Release Notes. Except for the DU validation service enhancements described in the Release Notes, the changes in this release will apply to DU Version 10.3 loan casefiles submitted or resubmitted on or after the weekend of March 23, 2019.

Please review the following updates, in addition to the <u>Release Notes</u>, to ensure that your integrated systems will be prepared to support this release.

Once your support process is complete, please notify the integration support team with the date of notice, release number and release date. If you are unable to support this release by March 23, 2019, please provide us with another date, which should not exceed 120 days from the date of this notice.

New, Modified and Deleted DU Underwriting Findings Report Messages

This release will introduce new messages, modify existing messages, and retire certain messages that are displayed in the DU Underwriting Findings report.

How will this affect my integrated system?

Integrated systems that parse the DU Underwriting Findings Codified Findings (XML file) or report data file (RES file) may require updates to support the message changes. Reference the table below for a preliminary assessment of the expected message changes.

Codified Findings File Update

The following Documentation Level Code updates will be made:

- Doc Level 135 will also be issued on high LTV refinance loans that are eligible for the appraisal waiver offer (in addition to DU Refi Plus appraisal waiver).
- Doc Level 136 is being retired as Selling Guide Announcement SEL-2018-06 removed the requirement for Form 1004MC, Market Conditions Addendum to the appraisal report.

Addition of Property Data ID

A Property Data ID field will be added. This field will be used in a future 2019 DU release.
