Fannie Mae Connect Delinquency Exception Details – Multiple SSID Report

The Delinquency Exception Details – Multiple SSID report in Fannie Mae Connect delivers servicers a detailed snapshot of delinquency status codes that were rejected and need to be corrected. This report provides delinquency status code exceptions for multiple Seller-Servicer IDs in one place and displays more than 5,000 exceptions.

For servicers that manage multiple Seller-Servicer IDs, this report provides a user-friendly alternative to the Delinquency Status Code Error report on the Asset Management Network (AMN). This report identifies exceptions created by illogical conditions or missing data resulting from the reporting of delinquency status codes, reason codes and related data. Codes classified as "Critical" must be corrected prior to the end of the reporting window otherwise the reporting will not be counted. A "Non-Critical" code means the data may be inconsistent but is not significant enough to reject the reporting. Having access to a snapshot of delinquency status codes allows servicers to review reason codes in one place and make corrections to the file before reporting to Fannie Mae. Data is refreshed daily between the first and twelfth day of the month.

This job aid provides detailed guidance for accessing the Delinquency Exception Details report in Fannie Mae Connect.
