Loan Quality Connect Release Notes

Overview of Enhancements

August 10, 2024

During the **weekend of August 10**, Fannie Mae will implement Loan Quality Connect[™] version 7.2. The system enhancements in this release include updates to the lender Resolution Queue, the Remedy Status Tab, and the Notice of Potential Defects feature.



Just Released

Loan Quality Connect users need at least one of the following roles to access this new functionality:

- Lender Remediation Specialist
- Lender Manager

Resolution Queue

Several enhancements have been made to the loan review Resolution Queue process in the LQCS 7.2 release including:

- There is an all-new layout for the Resolution Queue Business Intelligence (BI) data cards available for users which will enable users to manage their work queues more efficiently. The enhanced BI cards will clearly display up-to-date counts for loans that require user attention. The BI cards will now display the counts of loans with a Repurchase Alternative (RA) available, loans with comments to review, loans with tasks that require time-sensitive action, and loan reviews that were closed month-to-date.
- New columns have been added to the Resolution Queue: New Comment, Document Uploaded, Loan Viewed, and Task columns.
 - The 'New Comment column will indicate if Fannie Mae has added a new comment to a Loan Review that requires review by the users.
 - The 'Document Uploaded' column will clearly display if a document has been uploaded by Fannie Mae and is visible for a loan review by the users.
 - The 'Loan Viewed' column will display "Yes" or "No" for whether the loan review has been viewed by the users.
 - The 'Task' column will display any current tasks that require completion.
- A new "Concur to Repurchase" action button has been added to the Resolution Queue for the authorized users. The action button can be used to **concur** to repurchase on one or more loans directly from the Resolution Queue page.

Remedy Status Tab

Lenders will now be able to request a Repurchase Alternative (RA) via the 'Take Action' button on the 'Remedy Status' tab for loans when an RA has not been offered. This is counted as an available appeal for the loan review.

Notice of Potential Defect

If a Significant Defect is issued for a missing loan file on a loan review, the enhanced functionality will now issue a Notice of Potential Defect. The user will then be able to review and respond to the Significant Defect.
