## Technology Manager Registration Portal: UCDP Admin Registration

The **Uniform Collateral Data Portal** (UCDP) is a single portal that enables lenders to submit appraisal reports for properties backed by conventional mortgages that are sold to Fannie Mae or Freddie Mac. Through UCDP, lenders can upload appraisal data and view edits and submission details. If an organization is registering for UCDP first time or does not yet have an active UCDP Lender Admin, it can submit a request to designate a UCDP Lender Admin. To complete the UCDP Admin registration process, follow the instructions below:



1. Select UCDP Admin Registration on the Registration Portal page.
