1 Introduction

This guide provides technical direction to Fannie Mae business and technology partners who plan to integrate their systems with Fannie Mae's integration platform and the Uniform Closing Dataset (UCD) collection solution.

This guide is a supplement to the Fannie Mae Integration Platform Guide.

Please note Sections 1-5 of this document focus on the submission and retrieval of findings which are required to meet the 2017 UCD Mandate. Sections 6 -9 focus on UCD Transfer which is a new functionality for lenders to transfer a UCD file from a correspondent to an aggregator. This functionality is not required for the UCD mandate.

2 Overview

The UCD is a component of the Uniform Mortgage Data Program® (UMDP®), an ongoing effort by Fannie Mae and Freddie Mac to provide a common industry dataset to convey information on the Consumer Financial Protection Bureau's (CFPB) Closing Disclosure.

2.1 Authentication (For New and Existing Users)

The Fannie Mae integration platform and UCD collection solution utilizes HTTP basic authentication over SSL. In basic HTTP authentication, a request contains a header field of the form Authorization: Basic <credentials>, where <credentials> is the base64 encoding of SystemID and password joined by a colon. To authenticate to the integration platform each GET and POST request must include a valid credentials. All requests must be made using HTTPS. Requests made using HTTP will fail.

Please note the B2B Gateway will no longer use the "challenge and response" method when it looks to authenticate the user credentials. Users of this REST client service cannot connect to the B2B Gateway and call an Application Programming Interface (API) without sending the basic authentication in every request. Please see further instructions in the Appendix.

2.1.1 Getting Access for New Users of UCD

The new cloud gateway will require all new users to authenticate using a System ID. A new role, **AllowEndUserID_loginto_B2BGatewayAWS_API**, will be applied to specific existing User ID's on an exception basis, by the Fannie Mae FMSSO team. This new role will not be available for selection in Technology Manager. Please contact your Fannie Mae Integration Analyst with any questions related to an existing User ID.

3 Transaction Model Considerations

The UCD collection solution supports single-file submissions of the Uniform Closing Dataset (UCD), MISMO 3.3.0 XML file.

4 Request – Submit UCD

REST web service requests are made to the Fannie Mae integration platform and UCD collection solution via a synchronous communication model using standard GET and POST commands. Results are returned in a structured XML response with an embedded HTML version of the UCD Findings Report. The synchronous communication mode is set by the REST endpoint, and the request and response are processed in a single operation. If the UCD collection solution is unavailable and a request does not complete in a single operation within the specified timeout, the request should be sent again.

Integration partner systems may parse the UCD XML findings response and/or display the HTML.

4.1 HTTPS POST

Integration partners systems must be capable of generating a HTTPSPOST request. The payload (UCD/MISMO3.3.0XML) must be transmitted to the Fannie Mae integration platform and UCD collection solution in the message body of the HTTPS POST.

The following headers should be utilized in the HTTPS POST request.

Initial submission to the UCD collection solution: when a Case File Identifier (ID) is not provided in a MISMO 3.3.0 XML input file, a Case File ID will be generated by the UCD collection solution and assigned to the casefile. This Casefile ID should be persisted within the respective loan file in subsequent submissions to the UCD collection solution and other Fannie Mae business capabilities, as applicable.

5 Get Findings

5.1 REST Web Services

Integration partner systems can be configured to retrieve the UCD XML findings using a UCD Batch ID or Casefile ID assigned to a loan in a previous submission to the UCD collection solution.

GET findings returns the status of the specified operation and a UCD XML Findings Report.



GET findings may be specified as follows. Within the REST Endpoint URL:

- Replace <Batch-ID> with a unique UCDBatch ID or RequestID returned in a previous transaction.
- Replace <Casefile-ID> with a unique Casefile ID to search for a previous transaction.

Method	Parameter
GET	Batch ID - A unique identifier generated by the UCD collection solution and assigned to a UCD MISMO 3.3.0 XML input file.
	Casefile ID - A unique identifier generated by the UCD collection solution when a Casefile ID is not provided within the MISMO 3.3.0 XML input file.

5.2 HTTPS POST

Integration partner systems must be capable of generating a HTTPSGET request.

The following headers should be utilized in the HTTPS GET request.

5.3 UCD Findings Response

The UCD Lender Feedback Response Specification and UCD Lender Feedback Response Schema define the content and structure of the UCD XML findings and can be used to support XML parsing.

6 UCD Transfer Capability

With the implementation of UCD Release 2.0, correspondent lenders will be able to designate a UCD submission by its casefile ID to be transferred to a specific aggregator, who can then use the casefile ID to view the UCD data associated with it.

Integrated System Impacts

This will not affect my existing implementation of UCD submission. This additional functionality is not required to meet the UCD mandate. Relationship Establishment & Transfer UCD (two components of the new functionality) are being introduced. Establishing a relationship between two organizations is a pre-requisite to transfer a UCD. This functionality will only be available in the UCD GUI. Please refer to the UCD 2.0 Release Notes & UCD Release 2.0 Quick Guide documents for more information.

UCD Transfer will be available for directly integrated customers. For these customers, three (3) APIs will be available to transfer UCD data and to retrieve transferred UCD data.

Transfer UCD

This API can be used by an organization to designate the Casefile ID of the UCD they wish to transfer to a specific receiving aggregator (by their 5-digit Seller Servicer number.)

Required data in API request to Fannie Mae:

- Casefile ID
- Receiving aggregator (by their 5-digit Seller Servicer number)

Upon receipt of the transfer request, Fannie Mae will validate that the UCD file being transferred is owned by the submitter of the transfer request and that the two organizations that are participating in the transaction have an existing relationship within the Fannie Mae UCD Collection Solution.

Get UCD Casefile IDs

This API can be used by an organization to retrieve a list of Casefile IDs that have been transferred. The organization can make this request call by either a single Casefile ID or a date range (mandatory) and Seller Servicer number (optional) of the organization from whom the UCD was transferred.

Required data in API request to Fannie Mae

- Casefile ID or
- Data Range (with optional Seller Servicer number)

Fannie Mae will return a single Casefile ID or list of Casefile IDs with metadata about the transferred Casefile ID.



Get UCD Data

This API can be used by an organization to retrieve data for a UCD that was transferred. The request call would include the Casefile ID and indicator(s) of which document(s) the organization would like to retrieve (1. UCD Findings Report, 2. PDF of the Closing Disclosure, 3. UCD XML File).

Required data in API request Fannie Mae

- Casefile ID
- Get UCD Findings (Set to True or False)
- Get UCD PDF (Set to True or False)
- Get UCD XML (Set to True or False)

Based on the request call Fannie Mae will return an XML file with up to three (3) sections based on what the requestor asked for (1. UCD Findings Report, 2. PDF of the Closing Disclosure, 3. UCD XML File).

7 Transfer UCDs

7.1 Submit UCD Transfer (REST Web Services Call)

Upon submission, a response confirming if the transfer request was successful or not will be provided back to the submitter. If the UCD collection solution is unavailable and a request does not complete in a single operation within the specified timeout, the request should be sent again. The submitter of the transfer transaction should use the POST Method and the appropriate URL based on the environment.

7.2 HTTPS POST

Integration partner systems must be capable of generating a HTTPSPPOST request. The payload (UCD/MISMO3.3.0XML) must be transmitted to the Fannie Mae integration platform and UCD collection solution in the message body of the HTTPS POST.

The following headers should be utilized in the HTTPS POST request.

7.4 RESPONSE PAYLOAD

Fannie will validate that the UCD file being transferred is owned by the submitter of the transfer request and the two organizations that are a part of the transaction have an established relationship with each other. Sample success and error responses appear below:

Sample Error Messages (will be updated prior to production launch)

- Invalid Casefile ID (returned if casefile ID is not found or organization does not have rights to the casefile ID)
- No relationship exists between organizations (returned if the two organizations a part of the transaction do not have a relationship with each other)
- Casefile 1234567890 already transferred (UCD application allows only a single transfer)

8 Search For Transferred UCDs

8.1 REST Web Services (REST Web Services Call)

The request will contain a single casefile ID or a date -range w/ an optional seller servicer number to allow an organization to search for any transferred UCDs. Fannie Mae will return a single casefile ID or list of casefile IDs with metadata about the transferred casefile ID. If the UCD collection solution is unavailable and a request does not complete in a single operation within the specified timeout, the request should be sent again.

The submitter of the search call should use the GET Method and the appropriate URL based on the environment.

Integration partner systems must be capable of generating a HTTPSPOST request. The payload(UCD/MISMO 3.3.0 XML) must be transmitted to the Fannie Mae integration platform and UCD collection solution in the message body of the HTTPS POST.

The following headers should be utilized in the HTTPS POST request.

8.3 REQUEST PAYLOAD (Date Range for UCD's Received)

The request will contain a single casefile ID for which the submitter would like to get metadata about the transfer and its status;

NOTE: The <Request Header> container is optional and not required. The request will process even if it is omitted. The SearchRequestType is required. Also, the FromDatetime and Today Date and time are required. The SellerServicerNumber is an optional field.

9 Cancel Transferred UCD's

Upon submission, a response confirming if the cancel transfer request was successful or not will be provided back to the submitter. If the UCD collection solution is unavailable and a request does not complete in a single operation within the specified timeout, the request should be sent again. The submitter of the cancellation request should use the POST Method and the appropriate URL based on the environment.

Integration partner systems must be capable of generating a HTTPS POST request. The following headers should be utilized in the HTTPS POST request.

9.4 RESPONSE PAYLOAD

Fannie Mae will validate that the UCD CasefileID being cancelled is owned by the submitter of the cancel transfer request and that an existing transfer exists prior to the cancellation. Additionally, , the two organizations that are part of the transaction must have an established relationship with each other. Sample success and error responses appear below:

- Invalid Casefile ID (returned if casefile ID is not found or organization does not have rights to the casefile ID)
- No relationship exists between organizations (returned if the two organizations a part of the transaction do not have a relationship with each other)

10 Request – (Get UCD Case Details)

10.1 Rest Web Services

After a transfer transaction is complete and submitter has a list of casefile IDs, he can make a one-by-one call with a single casefile ID to request for the UCD XML, UCD Closing DisclosurePDF or the Lender Feedback XML (or any combination). The response will be a structured xml with (1-3 of the documents requested).

The submitter of the search call should use the GET Method and the appropriate URL based on the environment. The following attributes should be entered into the call to get back the data requested:

- Casefile ID (Required) Set Value to casefile ID (i.e., 1234567890)
- GetXML Set Value to True if you wish to receive the UCD XML (else False)
- GetPDF Set Value to True if you wish to receive the CD PDF (else False)
- GetFindings Set Value to True if you wish to receive the UCD LF Findings (else False)

10.3 Request via GET Call
